Other notes

- **Issue age:** If the owner(s) or annuitant(s) has a birthday (prior to the contract being issued) that causes their age to be higher than the maximum issue age for that fixed annuity, North American will not issue the policy.
- **Non-qualified stretch:** Non-qualified stretch is available at the time of death claim on most **inforce annuities** including traditional fixed, fixed index, and multi-year guarantee annuities. If the inforce contract had a guaranteed lifetime withdrawal benefit (GLWB), and has any remaining accumulation value, the GLWB will terminate and the remaining accumulation value (death benefit) is eligible for non-qualified stretch. **For new business**, non-qualified stretch is available on Performance Choice® 8, **NAC Guaranteed AllocationSM series**, and NAC VersaChoiceSM 10 (with or without optional enhanced liquidity benefit rider; not available if a GLWB is elected. *Non-qualified stretch is only available for natural owners; not on trusts, estates, corporations, etc.*)
- **Inherited IRAs/Inherited Roth IRAs (date of death on or before 12-31-19):** Products available for rollover from an established inherited IRA include North American Charter Plus series, **NAC Guaranteed Allocation series**, NAC Guarantee PlusSM series, Performance Choice® 8, and NAC VersaChoiceSM 10, and North American Income.
- **Inherited IRAs/Inherited Roth IRAs (date of death on or after 1-1-20):** Available on Performance Choice 8 and **NAC Guaranteed Allocation (5 and 7 only)** fixed index annuities. *Inherited IRAs are only available for natural owners; not on trusts, estates, corporations, etc.*
- **403(b):** Not available with the NAC VersaChoiceSM 10 and NAC BenefitSolutions® 10 fixed index annuities. \$50/month 403(b) salary reduction is only available on Performance Choice. 403(b) loans are not allowed on NAC Control. XSM, **NAC Guaranteed Allocation series**, and Income Pay ProSM.
